**NOTICE OF SPECIAL TOWN MEETING OF ELECTORS**

Notice is hereby given that a special town meeting of the electors of the Town of Anson, Chippewa County, Wisconsin will be held at the Anson Town Hall 13836 County Highway S South Jim Falls, WI 54748 on November 14, 2024, immediately following the completion of the public hearing on the proposed 2025 town budget, which begins at 7:00 p.m., for the following purposes:

- 1) To consider the adoption of a resolution by the electors at the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under Wis. Stat. § 66.0602, specifically a proposed tax levy which would exceed the allowable town tax levy for 2024 (to be collected in 2025) after adjustments, by 275%, for a dollar increase of \$300,000.00.

(Allowable levy limit = \$109,292.00; Total proposed levy limit = \$409,292.00)

- 2) To approve the 2024 total town tax levy (to be collected in 2025), pursuant to Wis. Stat. § 60.10(1)(a).
